TO: ALL CETA ACCREDITED SKILLS DEVELOPMENT PROVIDERS

Please take note of the following developments regarding accreditation transition to QCTO and registration of moderators.

1. CETA ACCREDITATIONS

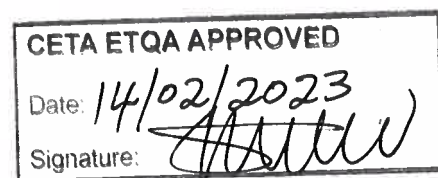
- 1.1. Kindly note that all CETA Historical Registered Qualification (HRQ's) will expire on the 30th June 2023, but SDPs still have up until 30th June 2024 to enroll learners on the system and last achievement date is 30th June 2027. This is a teach out period that SDPs must pay attention to.
- 1.2. CETA is now open for re-accreditation applications only for FETC: Plumbing and NC: Electrical Engineering, of which it will expire on the 05th December 2024, last date for achievement is 05th December 2028, re-accreditation doesn't require letter of intent.
- 1.3. Skills Development Providers are required to apply directly to QCTO for Occupational qualification as the NQF will be coming to an end as from 30th June 2023.

2. REGISTRATION OF MODERATORS

All moderators must be subject matter experts for all qualification that will be having interest to moderate, no moderators will be registered or re-registered as generic.

3. OTHER MATTERS

CETA ETQA Department will be conducting workshops regarding the transition of Historically Registered Qualifications (HRQs), as well as project monitoring templates and other relevant SDPs templates developed by QCTO. The workshop dates and the templates will be shared with SDPs in due course.



4. NEW ACCREDITATION APPLICATIONS

SDPs are advised that effective from the 1st of April 2023, must apply directly to QCTO for all new accreditation and re-accreditation applications for all the SETAs. QCTO will then transfer applications to the respective SETAs to proceed with file verifications and schedule site visits which will be conducted by Quality Assurance (QA) Officers in provinces together with QCTO and NAMB officials.

5. QUARTER 4 (1 January 2023 – 31 March 2023) SITE VERIFICATIONS

Just to re-iterate that site verifications that are conducted during this quarter will be issued with accreditation letters that expire on 30 June 2027 after the CETA Quality Assurance Unit has conducted site monitoring with QCTO to confirm facilities.
